General Advertising Information

The Helensville News is distributed on the first Tuesday of every month (excluding January) to approximately 5000 homes and businesses in Helensville, Parakai, Kaukapakapa, Waitoki, Woodhill, South Head and Shelly Beach. The paper is available online as well (at no additional cost to advertisers), with a growing subscriber base. Copy deadline for each issue is the Friday three weeks prior. Publication and deadline dates for coming editions are on the back page of each issue, and on the paper's website, www.helensvillenews.co.nz.

Please provide a fax number or email address for proof reading. Unless copy is received by deadline, there is no guarantee that you will receive copy to proof read. Photographs will be returned within one month of publication if requested.

Discounted advertising rates are offered for multiple booked insertions. A 5% discount applies to three consecutive bookings. A 10% discount applies to either six consecutive issues, or six alternate issues over 12 months. A 20% discount applies for 12 consecutive insertions. (Note: there is no issue in January). Prices quoted are per issue, and exclude GST (discount percentages are approximate).

There is no extra charge for minor monthly alterations to multiple-insertion advertisements.

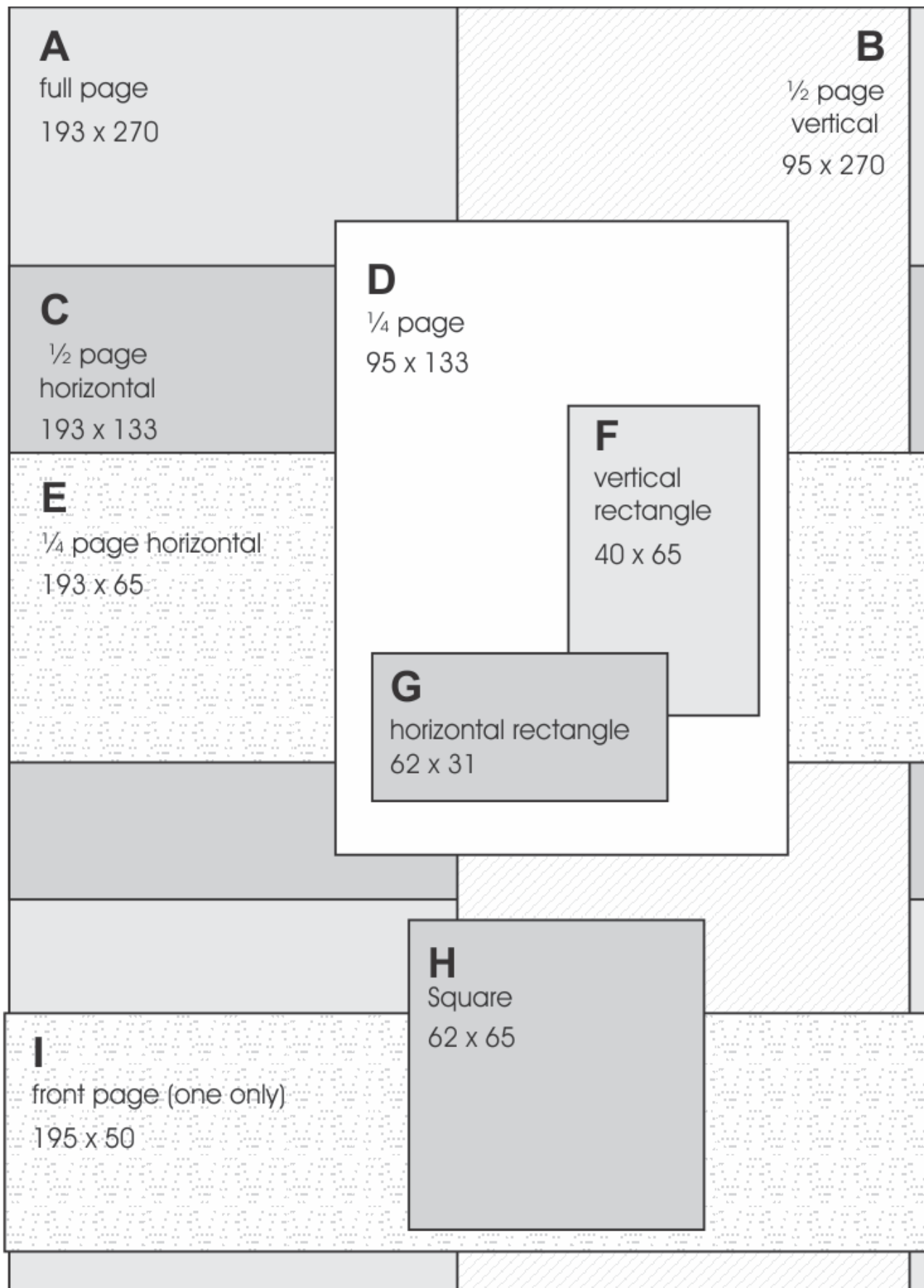
Advertisements supplied as finished artwork should either be in press-ready PDF format, with fonts converted to outlines, or as 300dpi JPEG or TIF images. Exact dimensions will be supplied on request. Note: Helensville News is printed in black and white, so any artwork or images supplied should be grayscale, not colour (although we can convert if necessary).

Digital images supplied for editorial use may be colour or black and white, but should preferably be a minimum of 1mb in size (average digital camera and mobile phone images are 2-5mb).

Cancellations of booked advertisements should be made no later than the deadline of the issue booked. Later cancellations will incur booking charges as detailed on the booking form.
